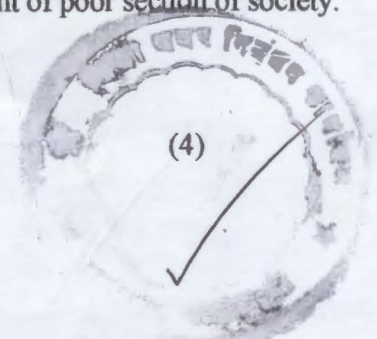
ACTIVITIES OF THE TRUST:-

Honorary Trustee or Trustees or inviting Trustee or Trustees may be appointed by the Settler/ Main Trustee/ Author with the consultation of Trustees.

The Board of Trustees shall do everything necessary, suitable and proper for accomplishment of these objects within the constitutions of India, but not limited.

The Board of Trustees have right in a regular meeting to accept the resignation of any of its trustees or member appointed by The Board of Trustees.

Be it noted that ~~in case Mr. Rashid Jamal~~ becomes ill or he ~~may~~ not be able to function as Main Trustee / Settler/ Author, Mr. Rashid Jamal may nominate or appoint any member of his family whom he may think suitable person in place of him and the person so nominated or appointed will have the same power what so have given to Main Trustee / Settler/ Author.

JURISDICTION:-

The court of East Champaran alone shall have Jurisdiction.

The meeting of the Board of Trustees shall be convened two times in a year but when occasion so arises the meeting may be convened ~~more than two~~ or whenever it becomes necessary.

The Trustees with the consultation of Main Trustee/ Settler/ Author can change, alter or delete/ amends, modify any clause or clauses for smooth functioning of the TRUST.

DISSOLUTION OF THE TRUST:-

The Trust can be dissolved by the unanimous resolution of the TRUSTEES.

GENERAL:-

The Board of the Trustees shall have the power to frame by laws of the TRUST.

All pleadings including plaints, written statements, counter affidavit, application, affidavit etc will be signed by the Chairperson himself or a person duly appointed by the Chairperson.

Now the Main Trustee/ Settler/ Author and both the Trustee out of their free will and volition without coercion in state of sound mind and good health, execute this deed of TRUST to be of avail in future.

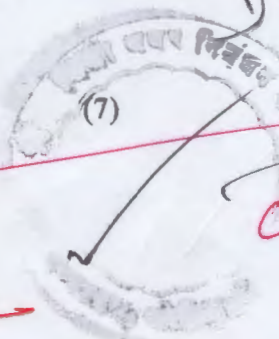
